**ប្រាសាទ កោះកេរ្តិ៍ - Koh Ker** is a sacred urban complex featuring numerous temples, sanctuaries, sculptures, inscriptions, wall paintings, and archaeological treasures. Constructed over a span of 23 years, it served as one of the two rival capitals of the Khmer Empire, the other being Angkor. Koh Ker was the sole capital of the empire from 928 to 944 CE, under the reign of King Jayavarman IV. This ancient site, rich in history and culture, has been recognized as a UNESCO World Heritage site for its significant contribution to Cambodia's architectural and artistic legacy.



# GENERAL INFORMATION

## Siem Reap, an Ancient City of Cambodia

Siem Reap is Cambodia's top destination, known for its proximity to the world-famous Angkor Wat temples. This lively city offers a mix of ancient history, rich culture, and modern comforts. ### Visa Requirements and E-Arrival Card

Most visitors to Cambodia require a visa, which can be obtained upon arrival at airports or land border crossings. Ensure your passport is valid for at least 6 months after your departure from Cambodia and has at least two blank pages.

All travelers must complete an e-immigration application online within 7 days before arriving in Cambodia

Here's how to use the CeA scheme:

1. Register: Download the mobile app, take a photo, and upload your passport information.
2. Complete the E-Arrival Card: Fill out the required information in the e-arrival card.
3. Generate QR Code: After submitting the application, a QR code will be created. Save this code on your phone or print it to present at immigration upon arrival.

### Time Zone

Siem Reap follows Standard Time at **GMT+7.**

### Climate

Siem Reap enjoys a tropical monsoon climate, characterized by two main seasons:

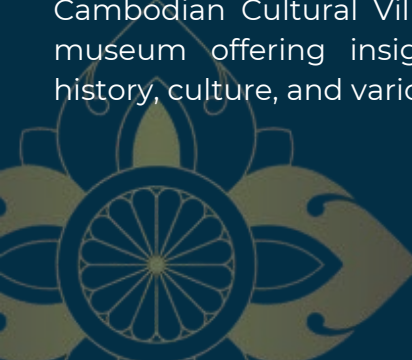
